Wow! John Prine is coming to town! For some of us, that really is better than Santa Claus or a plethora of other classy characters.

Sitting here faced with the task of writing something about John Prine is daunting! It takes little time to recognize that this newsletter is not the forum to recount the four decades of his prolific What has songwriting career. the struck me is crossgenerational appeal he inspires. Hearing from some of the local 30 something year olds their enthusiasm for this concert demonstrates that fact.

With 20 plus albums to his credit - with songs covered by Bonnie Raitt, Bette Midler, Johnny Cash and Norah Jones – he has established a life long music career. In the 1960's this native of Maywood, Illinois started hanging out at the Old Town School of Folk Music in Chicago with his brother Dave, a fiddle player. He began his professional career with his friend, the late Steve Goodman, in the early 70's. From those Chicago roots he established a friendship with John Belushi which led him to a spot on the second season of Saturday Night Live. In 1991 his album, The Missing Years, was With nearly a quarter produced. million copies sold, it won Grammy for Best Contemporary Folk Album: "exactly-odo, guaismodo". His latest album, Standard Songs for Average People, is а compilation of covers he produced with Mac Wiseman. Thankfully, his bout with cancer has not stopped this musical mystic.

Whether you have been a fan of his music since the 70's, a by-standing listener to your parent's music, or a recent convert, you have your own favorite lyrics. In 2001 I had the opportunity to attend his concert at Ravinia outside of Chicago. After the show my daughter said, "Mom, I knew practically all of those words." During Saturday chores, she too inadvertently grew up loving his music. His concert brought back decades of lyrics, plus the infusion of his newer songs. One thing you can count on from a John Prine concert is that you will go home with a deeper appreciation of his take on our "big old goofy world."

## **Treasurer's Report**

The Alaska Folk Festival stays solidly in the black this year, thanks again to all the supporters and volunteers. Our main sources of income are memberships (\$26,800), merchandise (\$26,700) and program ads(\$3600). Since the beginning of our fiscal year on Oct 1, 2007, our total income to date is \$61,600.

On the expense side, with a couple of bills still estimated, it looks like we have spent \$58,900. Our largest expenses were the hall, merchandise, guest artists, sound engineering and printing. Our profit from merchandise sold is \$10,800 which includes about \$1000 of previous years' unsold merchandise.

### **Thoughts on AFF Donations by Mike Sakarias**

The Annual Membership Meeting of the Alaska Folk Festival evolved into a protracted discussion of the role of the Alaska Folk Festival in giving monetary support to events and groups.

I am not, presently, a member of the AFF board, so am not defending myself against criticism offered at the Annual Meeting. But, I have been involved with the AFF as a major volunteer since 1989, as a board member for all but two of those years, and as President for several of those.

I offered to the AFF Board that I would write up some of my thoughts on the Annual Meeting discussion and give some background.

First, from the Articles of Incorporation (with identical language in the Bylaws), the Purpose of the AFF:

The purpose of the corporation is to operate and perpetuate the Alaska Folk Festival and to maintain its traditions of free public admission and the encouragement of non-professional performers; and to do and engage in any and all lawful activities that may be incidental or reasonably necessary to the foregoing purpose.

A flexibly written Purpose.

Over the years, the AFF has been a member of the Anchorage Folk Festival (on and off), of KTOO (usually), of the JAHC (newly) and the Folk Alliance (just a couple years, a decade ago).

The AFF has helped the Juneau Contra Dancers (as has JIF), have been helping the Coffee and Jam (an event organized by the Juneau Contra Dances), donated money to the Pelican Boardwalk Boogie to get it started, donated money to the Dance Fest to get it going, and (after a lot more discussion), voted to donate in its second year. This year, we declined as we really want the Dance Fest to fly, on its own. We DO realize that the major product of the AFF, Inc it the Festival itself, but see these other events as part of the whole.

All of it was spent with the idea and intention of "perpetuating the AFF" by the "encouragement of non-professional performers."

I think it can be argued that a very strict interpretation of the "no donations to anyone" suggestion would not be a healthy thing for the AFF, long term. But, once you allow for some donations, it becomes a question of which ones?

Should the AFF be doing this? There is plenty of room for discussion on both sides. Are there legal

questions? Some think there are. Can this all be resolved in a one hour, once a year meeting of the interested parties during the Folk Festival? No. And, it certainly wasn't.

What are the essential ingredients for the annual Alaska Folk Festival? Money, musicians, volunteers and an audience -- and, critically, a volunteer subset -- people willing to work on the Board of Directors.

It is still the case that 70% of the cost of each AFF is paid for by memberships. It is still the case that one of the prime goals of the AFF is to provide a venue for amateur musicians to perform. It is still the case that without an appreciative audience the money would suffer, fewer people willing to donate money. And, volunteers are essential, too; there isn't enough money to pay people to do all the things that need doing.

And, there is that special subset of volunteers: the Board of Directors. I want to present on a few thoughts from my experience on the Board and as AFF president.

While, generally, non-board AFF folks realize that being an AFF board member is a lot of work, no one, unless you've been on the board, truly understands what that means, how much energy and time is actually involved.

The average number of terms for an AFF board member is one three-year term. More than a few board members have resigned after one year, or even before one year. Very few past board members volunteer much after they have been on the board. Very few run for second terms. And, a tiny handful run for a third or forth term.

A three year term seems like a long commitment. But, during first year someone is on the board and helps with the Festival, most people are on a VERY steep learning curve. Their utility as a first year board member is hampered by inexperience. The second year a person is pretty useful, but still learning. But, it is only in the third year, that they actually know what they are doing. Then, if they are one of the many board members, they do not run for re-election and all that experience leaves the board.

The AFF board, to operate best, needs a mixture of people with the institutional knowledge and experience (most easily acquired by helping the AFF happen, at the board level, for many years) and enthusiastic, new folks. A few board members have hung around for many years. Currently, Greg McLaughlin is the board member with the most experience, Though I am not on the board, currently, I am continuing to volunteer lots of hours. But, when Greg and I are 85, we're not going to be helping run the AFF, anymore. Who will take our places?

This brings me back to the Annual Meeting. "Thanks for a great Festival" is nice to hear, but it is very easily counterbalanced by getting chewed on for doing things that you felt were in the best interest of the Festival and its goals. Each year, we have a very hard time finding people willing to be members of the board. We are successful in money, memberships and in the mass of volunteers needed to do the work during the Festival, but not always successful in getting good people on the AFF on the board to work on organizing the whole thing. Constructive suggestions are one thing, but criticism at events like the Annual Meeting could well discourage people who otherwise might have been thinking, maybe running for the board, some year. Why voluntarily make yourself a target for criticism? Then again, maybe some of those folks with the strongest feelings about how the AFF should be run will step forward and help run it.

I want to see the AFF hit AFF50 and more. But, that is not a given. It will not happen without good people working on the board, carrying on the traditions.
